  - -There is not enough time for proper consideration of all questions or detailed responses or right of reply.
  - -Disappointed re Arcade Site delay, vision, plan

  - -Many questions were not answered. We were told this was because there was a lack of time.

- -Community Forum dominated by the usual suspects who were allowed to speak at length. Chair should be stronger in enforcing his stated request for conciseness.
- -I remain to be convinced that there is real consultation with the residents.
- -Need young members. Need members of our ethnic communities apart from white.
- -Brings in NIMBYS and usual suspects only
- -The response from the Developer was too general. We were asking about Willowfield School which was only a minute / almost absent part of the initial proposal.
